

MINUTES FROM THE

EXTRAORDINARY GENERAL MEETING IN

NORDIC SEMICONDUCTOR ASA

The Extraordinary General Meeting of Nordic Semiconductor ASA was held on February 6, 2024 at 9:15 am. The meeting was carried out as a video conference from Nordic Semiconductor ASA's premises in Oslo, Norway.

The Board was represented by Birger K. Steen (chair) and Anita Huun (Chair of Audit Committee). The Nordic Semiconductor management was represented by Vegard Wollan (CEO), Linda Pettersson (SVP Legal & Compliance) and Pål Elstad (CFO).

Item 1. Opening of the Meeting by the Chair and register of the shareholders present (no voting).

The meeting was opened by board member Anita Huun, who was appointed by Chair Birger K. Steen. A register of the shareholders present was taken, both advance votes, on the web or by proxy, as set out in Appendix 1. Company Secretary Christian Skovly-Guttormsen stated that 114,084,344 of the Company's 192,305,515 shares (59.32%) were represented at the meeting.

Christian Skovly-Guttormsen was elected to chair the meeting and Pål Elstad was elected to cosign the minutes, with votes cast as set out in Appendix 2.
